Introduced By: Senators Pearson, and Picard Date Introduced: February 05, 2015 Referred To: Senate Judiciary

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 3 of Chapter 505 of the 2013 Public Laws entitled "An Act Relating 2 To The Consolidation Of The Cumberland, North Cumberland, Cumberland Hill, And Valley 3 Falls Fire Districts Into The Cumberland Fire District" is hereby amended to read as follows: 4 Section 3. Governing Body 5 The initial governing body of the consolidated Cumberland Fire District shall be a Fire 6 Committee. Membership on said committee shall be a public office. Members shall hold no other 7 public office. If any member shall hold any other public office, his or her office as a member of 8 said committee shall immediately become vacant. 9 Beginning no later than November of 2014, with the regularly scheduled general election, 10 seven (7) members of the Cumberland Fire Committee shall be elected. Each of the five (5) council districts shall elect one member, with two (2) members being elected from the town at 11 12 large. It shall be a non-partisan election for a two (2) year term. The winning candidates shall be 13 sworn in immediately after the election results are certified. Any vacancy in the membership of 14 the Committee shall be filled by written ballot of a majority of all the members of the Town 15 Council for the remainder of the term of office, provided that the person selected to fill said 16 vacancy shall be a qualified elector from that district. A vacancy in said membership of the 17 Committee shall occur if a member dies, resigns from office, ceases to be a resident and/or elector 18 of the district in which elected, or shall be absent for four (4) consecutive regular meetings or six 19 (6) regular meetings within a twelve (12) month period unless said absence(s) are excused by a

- 1 majority vote of the whole Committee. Any and all elections, provided for under this act, shall be
- 2 governed by, and subject to, the provisions of title 17 and shall be administered by the state board
- 3 of elections and the town of Cumberland board of canvassers.
- 4 SECTION 2. This act shall take effect upon passage.

- 1. that the Superior Court had previously determined that the Albion Fire District is a public body subject to the Open Meetings Act, R.I. Gen. Laws § 42-46-1 et seq;
- 2. that the Superior Court had previously concluded that the notices for the Albion Fire District's May 11, 2010, August 10, 2010 and September 21, 2010 meetings violated the Open Meetings Act;
- that the Superior Court had previously determined that a genuine issue of material fact exists as to whether the above-mentioned violations were willful or knowing under R.I. Gen. Laws § 42-46-8;
- 4. that in order to resolve this case, Defendant, the Albion Fire District agrees to pay to the State of Rhode Island five thousand dollar (\$5,000.00), such amount to be paid by the Albion Fire District within thirty (30) days of signing this Consent Judgment, and no other costs or fees shall be assessed;

- 5. that this Consent Judgment shall become effective on the date of its entry and is binding upon the Albion Fire District, its agents, servants, successors, assigns, and all persons, corporations or entities acting through or for it.
- 6. In consideration of the Albion Fire District's payment of five thousand dollar (\$5,000.00), this case is dismissed.
