3 Tax Assessment Levy

6 **RESOLUTION:** That the Cumberland Fire District shall collect a tax levy

7  
8 **BE IT RESOLVED BY THE CFD COMMITTEE AS FOLLOWS:**

9  
10 **SECTION 1:** The Cumberland Fire Committee hereby orders the assessment and collection of a  
11 a tax on the ratable real estate and tangible personal property in a sum not less than  
12 7,282,671.00 or a sum not more than \$7,425,469.00

13  
14 **SECTION 2:** Said tax is for ordinary expenses, charges for the payment of interest and  
15 other indebtedness, in whole or in part, of the fire district and for other purposes  
16 authorized by law.

17  
18 **SECTION 3:** The Cumberland Fire District Tax Collector shall proceed and collect  
19 said tax from persons and estates libel therefore unless by law otherwise provided.

20  
21 **SECTION 4:** Said tax shall be due and payable on the 15<sup>th</sup> of July, 2017.

22  
23 If the first installment or any succeeding installment of taxes is not paid by the last date of  
24 the respective unpaid balance period or periods as they occur, then the whole tax or  
25 remaining unpaid balance of the taxes, as the case may be, shall immediately become due  
26 and payable and carry until collected a penalty at the rate of twelve (12%) per annum on the  
27 full unpaid balance.

28  
29 However, said tangible personal property and real estate taxes may be paid in  
30 quarterly installments as follows:

- 31 1. The first installment of twenty-five percent (25%) on or before the 15<sup>th</sup> day of  
32 July, 2017.  
33 2. The second installment of twenty-five percent (25%) on or before the 15<sup>th</sup> day of  
34 October, 2017.  
35 3. The third installment of twenty-five percent (25%) on or before the 15<sup>th</sup> day of  
36 January, 2018.  
37 4. The fourth installment of twenty-five percent (25%) on or before the 15<sup>th</sup> day of  
38 April, 2018.

39           5. Each installment of taxes, if paid within five (5) business days of each installment  
40           due date will be free from any charge of interest

41  
42   **SECTION 5:** All tangible personal property and real estate tax bills totaling one hundred dollars  
43   or less for the year will be due in full on or before the 15<sup>th</sup> day of July 2017 and may not be  
44   paid in quarterly in installments

45  
46   **SECTION 6:** Any of said taxes not paid on or before January 15, 2018 shall be collected  
47   by levy upon sale of the real estate upon which it is assessed or by other due process of law.

48  
49   **SECTION 7:** There shall be a minimum bill calculated of twenty-five dollars (\$25.00).

50  
51   **SECTION 8:** This levy shall take effect upon its passage and all resolution or portions thereof  
52   which are inconsistent herewith are hereby appealed.

55   **NOW THEREFORE, BE IT RESOLVED BY THE CUMBERLAND FIRE DISTRICT AS FOLLOWS:**

57           **Resolved:** The Cumberland Fire District shall collect a tax levy in a sum not less than  
58           \$7,282,671.00 or a sum not more than \$7,425, 469.00.
