Board of Commissioners Cumberland Fire District July 16,2019

Board Members;

Attached are the monthly reports of activity for the month of JUNE 2019. The run report shows 388 response calls for the month and broken down by category.

Engine 4 3<sup>rd</sup> Platoon, provided a Fire Truck Ride to a student at J J McLaughlin Elementary school as part of a fund raising activity for the school.

Engine 4 & Ladder 1 3<sup>rd</sup> Platoon , set up a challenge course an assisted in running students that are participating in the day camp, at the High School.

4<sup>th</sup> Platoon, welcomed the winner of the Fire Chief for a day, from Mercymount Day school on June 27 and provided her with a range of demonstrations and opportunities at each station.

I continue to work with the Finance Director and Finance Sub Committee in managing the budget for FY 20.

Engine 1 was involved in a vehicle accident, July 15, no injuries were reported, vehicle damage to both vehicles, Engine 1 is still operational, case has been submitted to VFIS.

The department assisted in the July 3, fireworks show with no issues to report.

All the Firework sales tents that went up were inspected for compliance, and no injuries can be related to the firework sales.

We had a small fire at 500 Mendon Road, which started on the outside of the building and caused some exterior damage. The resident was not displaced because of the fire.

We still are seeing a large volume of home sales, and new construction happening in the Town.


