Chief's Report for November 2021

Board of Commissioners Cumberland Fire District November 23, 2021

Commissioners,

The Cumberland Fire District responded to 445 calls for service for the month of October. Fire responses included a residential fire on Scott Road. The home was located over a thousand feet off the road and the nearest fire hydrant was located over a half a mile away. Mutual aid water tankers were called to the scene and out of town departments filled our stations. The powerlines to the home were pulled off the house. Improper grounding to the electrical system was the cause of the basement fire.

The Scott Road fire also raised concerns when one of our radio repeaters went down and backups did not properly activate. Our radio vendor CyberComm addressed the issue and also gave options to improve our system. Any upgrades or repairs will go to the Town of Cumberland as this is a shared system with police and ems.

The AFG grant is open, we will once again request an upgrade to our radio system as well as a new fire engine. Our grant committee is currently working on gathering current data and we have attended the informational session with FEMA and Senator Jack Reed at the Providence Public Safety Complex. The SAFER Program is 100% funded for three years for 2021 also. Although, I am not sure if we will qualify since our current SAFER expires in February.

The Smithfield Fire Department received an AFG Award for a live fire training building. This grant was put in as a regional grant to include Cumberland. Our share would be approximately \$5,500 depending on the final design and if more communities are interested in this project. The advantage of this facility would be sending on duty personnel down Route 116 to Smithfield instead of organizing platoons to the state facility in Exeter. I will inform the board as this project moves forward.

We have received a \$5000 grant for new AED's. This will upgrade all our frontline vehicles and our older models will still be maintained on our reserve units. Thank you to PhRMA and Senator Ryan Pearson for your generosity and assistance.

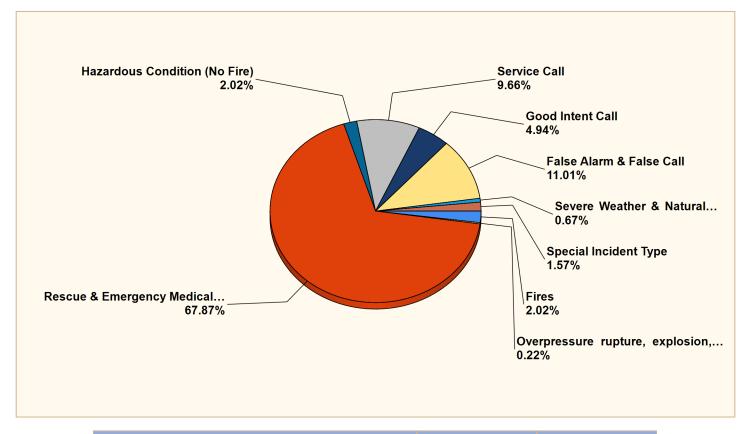
